



SPHL Booster Club Regulations

Team booster clubs are an extension of the member team and cannot pay or provide players additional compensation beyond what is permitted pursuant to their Standard Player Contract and SPHL Rules, Regulations, and Bylaws. Payment or compensation by a booster club or an individual member is considered a salary cap violation, and the team shall be subject to penalties as provided under SPHL rules. In addition, depending on the severity of the infraction, the SPHL may require the disbandment of a team's booster club as part of the disciplinary action.

The booster club may present gifts or de minimus rewards to players for certain honors if pre-approved by the SPHL office.

If the member team provides the items used by the booster club to generate revenue, this revenue may not be distributed back to the team's players.

Member teams cannot make cash donations, or other gifts in kind to the booster club, that are subsequently distributed to the players.

Before the start of each season, each booster club must submit a detailed list of all planned cash or cash equivalent gifts to be given to SPHL players during the upcoming season.

Items or events not covered below must be submitted to the League Office for approval.

The following items **are permitted** to be provided by SPHL booster clubs:

- Apartment furnishings: linens, pillows, dishes, cookware, etc. (ex., basic housekeeping needs)
- Juices, snacks for road trips
- Welcome cookout/dinner/party, holiday dinner, end-of-season awards dinner/party

In addition, SPHL booster clubs are permitted to purchase groceries for players as follows:

- Booster clubs may spend a **maximum** of \$100.00 per player, per month
- Players may receive their monthly \$100.00 in the form of a gift card to a local grocery store if the booster club does not wish to purchase the groceries themselves.
- Groceries/gift cards may be purchased/given one time per month, at the start of the month
- Additional gift cards/purchases are not permitted during the month based on player changes within an apartment
- Booster clubs must spend the same amount on **all** players every month
- If spending less than the \$100.00 limit per player, the remaining monthly difference may not be distributed to players in any fashion.



The following items **are not permitted** to be provided by SPHL booster clubs/members:

- Cash payments of any kind
- Restaurant gift cards for a road trip. This would exceed the daily per diem limit as set by the Board of Governors
- Any portion of the revenue of an item sold with a player's name or likeness (ex., photo buttons, cards)
- Revenue from team Chuck-A-Puck promotions sponsored or run by the booster club
- Payment for player appearances at special events (ex., meetings, sponsor events, etc.)

The following items **require league approval** before they may be provided by SPHL booster clubs/members:

- Maximum \$50.00 gift certificate/card, per award, for Player of the Month awards
- Maximum \$25.00 gift certificate/card for hat trick or shutout
- Christmas and/or birthday gifts
- Any gifts to players not covered in these regulations
